### Setup is Progressing at a Quick Pace

#### Board of Directors Established

Directors of the Canadian Supply Chain Sector Council have been selected, through a process that took into account numerous requirements. Small, medium-sized and large corporations in a variety of industries, as well as relevant associations and educational institutions – from across Canada – are essential participants in the Council; their views of the sector will be accessed through representatives on the Board.

With a Board of only 19 members, meeting all of these needs was certainly challenging, but the Board makeup is an achievement; members cover the spectrum of the Canadian supply chain sector and can be expected to speak for all of its stakeholders. In addition, members are individuals recognized for their knowledge of, experience in and commitment to the supply chain field. Collectively, the group is well situated to understand the diverse needs of the Canadian supply chain labour market at all levels, and to delineate appropriate and realistic ways to meet those needs.

During a preliminary conference-call meeting of the Board, held on July 25, members were provided with an overview of the Council's development and activities to date, and information about the anticipated role of directors and the Board. The first formal meeting of the Board is to take place in October 2006 in the Greater Toronto Area. Subsequent meetings will be held in other cities across Canada.

Included in the list of initial assignments for the Board are identification of the mission, mandate and values of the Council, and strategic planning and governance development.
